Protecting Contraception Access (S.4381) - Cloture Motion Rejected

Vote (**51-39**)

Motion to Invoke Cloture: Motion to Proceed to S. 4381

The Senate (killed) failed on a motion to invoke cloture on the Schumer (D-NY) motion to proceed to S.4381, the Right to Contraception Act. The bill would guarantee the right for people to obtain and use contraceptives and for health providers to prescribe contraceptives and give information related to contraception, free from government interference.

Fiscal 2025 Military Construction-VA Appropriations (H.R.8580) - House Passage

Vote (**208-194**)

On Passage: H R 8580 Military Construction, Veterans Affairs, and Related Agencies Appropriations Act, 2025

Passage of the bill, as amended, that would provide \$380.3 billion in fiscal 2025 for military construction programs and the Veterans Affairs Department, a nearly 10 percent increase from the enacted fiscal 2024 level. The bill would allocate \$147.5 billion in discretionary funding, including more than \$129 billion for the Department of Veterans Affairs, a \$6 billion decrease from the fiscal 2024 enacted level.

It would provide \$112.6 billion for veterans' medical care programs. It also contains \$495 million for veterans' memorial benefits at the National Cemetery Administration.

It would allocate nearly \$18 billion for military construction programs. It also would allocate \$1.1 billion for 11 barracks projects, with another \$2 billion designated for military family housing projects.

It would include \$547 million in community project funding, for 23 military construction projects. It also would prohibit the use of funds provided by the bill to fly a flag at a VA facility or national cemetery other than the U.S. flag, the flag of a state, territory, the District of Columbia, a Native American tribe or an armed force's flag. It also would prohibit funding for gender-affirming surgical procedures or hormone therapies and abortion-related care or counseling. The bill would prohibit the use of funds to enforce three Biden administration executive orders dealing with diversity, equity and inclusion in the federal workforce and advancing racial equity through the federal government. It also would bar the use of funding to carry out executive

orders related to various topics including federal government decarbonization and addressing climate change.

International Criminal Court Sanctions (H.R.8282) - House Passage

Vote (**246-152**)

On Passage: H R 8282 Illegitimate Court Counteraction Act

Passage of the bill that would require the president to impose sanctions on International Criminal Court officials and others involved with bringing ICC indictments against certain "protected" persons, including Israeli and U.S. officials.

Under the measure, sanctions could include the denial or revocation of visas to enter the U.S., asset freezes on property in the U.S., and restrictions on transactions in financial, securities and currency markets. Protected persons would include U.S. persons (explicitly including current and former members of the U.S. military and elected and appointed U.S. officials), as well as citizens of U.S. allies who are not party to the ICC (such as Israeli officials).

It would rescind funds appropriated and made available for the ICC, effective on the date of the bill's enactment. It also would prohibit future appropriations to the ICC.

Condemn and Counter Antisemitism (H.Res.1215) - House Passage

Vote (**368-0**)

**On Motion to Suspend the Rules and Agree, as Amended: H RES 1215
Calling on elected officials and civil society leaders to join in efforts
to educate the public on the contributions of the Jewish American
community**

Motion to suspend the rules and agree to the resolution, as amended, that would call on elected officials, faith leaders and civil society leaders to condemn and counter all acts of antisemitism.

It also would call on the executive branch, state and local leaders to educate the public on the contributions of the Jewish-American community and uplift Jewish voices as well as to take "all possible steps" to ensure the safety and security of Jewish-American communities. It also would call on educators and administrators to combat antisemitism in academic settings.

Motion agreed to by a vote of 371 - 0:
